### **Auditor General's report**

#### Audit opinion - Qualified

Except for the matters reported below in my Basis of qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's/Committee's governance arrangements; and
- that the Council/Committee does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

#### Basis of qualification

In my opinion, the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

The Annual Governance Statement does not accurately represent the Council's governance and internal control arrangements. The Council has asserted that it has maintained an adequate system and internal control.

My audit identified the following:

- the Clerk's contract of employment is insufficient to properly establish the terms and conditions of employment and there is a lack of clarity regarding the Clerk's salary.
- During the year, the Council let contracts worth £2,747 to a Council employee. It is not clear why this work did not form part of the employee's duties and therefore I am unable to conclude whether or not the expenditure was lawful.

### Other matters arising and recommendations

There are no further matters I wish to draw to the Council's attention.
